## Biographical notes



**Johanne Clouet** holds a Master of Laws from McGill University, a Master of Notarial Law and a Ph.D. from the University of Montreal. Her research activities focus on family law and the law of persons. Her doctoral thesis won the Thémis Prize for the best thesis (2016) and was published by Éditions Thémis. Prior to joining the Faculty of Law of the Université de Montréal, she conducted a postdoctoral project with the Antoine-Turmel Research Chair on the Legal Protection of Seniors (Université Laval). Her research focused on the protection of the elderly through the Quebec Charter and on advance directives in health care. Professor Clouet teaches in the Master's program in notarial law and in the Bachelor's program in law, in addition to being an associate professor at the Institut des sciences, des technologies et des études avancées d'Haïti (ISTEAH).



**Ayelet Blecher-Prigat** is Professor of Law and serves as the Dean of Law School at the Academic College of Law & Science in Israel. Professor Blecher-Prigat holds degrees in law from Columbia Law School (LLM, *Kent Scholar* and JSD) and from Tel Aviv University (LLB, *magna cum laude*). Her research focuses on family law and theory, children's rights, and law and religion in Israeli law. Her work has been published in leading Israeli law journals as well as in the *Arizona State Law Journal*, *Harvard Journal of Law & Gender*, *George Mason Law Review*, and *Columbia Human Rights Law Review*.



**Audrey Ferron Parayre** is a professor at the Section de droit civil, Faculty of Law, and membre of the Centre for Health Law, Policy and Ethics at the University of Ottawa. She holds a master's in public health and a doctorate in law, and is working on persons and health law interdisciplinary projects. She is particularly interested in informed consent and its implementation in different clinical contexts, such as general medicine, psychiatry, and obstetrics-gynecology.



**Philip D. Jaffé** is a full professor at the University of Geneva, Switzerland, and the founding director of its Centre for Children's Rights Studies (CIDE) (2008-2020). In 2018, he was elected to the United Nations Committee on the Rights of the Child. A clinical and a forensic psychologist trained in Switzerland and in the USA, for many years, his academic and professional activities have focused on children's rights, in particular child protection and the participation of children. Beyond the traditional "teach, research, publish or perish missions" required by a leading university, his vision of academic life is to branch out in the community at large as a science practitioner and educator. **Ido Katri** is an Assistant Professor at Tel- Aviv University School of Social Work in collaboration with the Faculty of Law. Ido holds a doctorate (SJD) from the University of Toronto where he was both Pierre Elliot Trudeau Foundation and Vanier Canada scholar. Ido teaches and researchers in the field of Legal and Critical Theory, as well as Administrative, Equality and Welfare Law, with a focus on issues of trans rights, gender and sexuality, race and racialization, subjectivity and subjection.



**Pamela Laufer-Ukeles** is Professor of Law and Healthcare Administration at the Academic College of Law and Science in Hod Hasharon, Israel. She is originally from the U.S. where she was Professor of Law at the University of Dayton School of Law. Prof. Laufer-Ukeles received her J.D. from Harvard and her B.A. from Columbia College, Columbia University in Philosophy and Economics. She was a Fulbright Fellow and a Harvard Kennedy Scholar in the field of bioethics. Her areas of expertise include tort law, family law, children’s rights, elder law, healthcare law and bioethics. Her articles on surrogate motherhood, informed consent in the context of reproductive technologies, children and women’s rights, the harms of commodification and the importance of caregiving to society have been published in numerous books and journals and she is a regular visitor at Universities worldwide to discuss these topics. Most recently she published a co-edited collection of articles from across the globe titled, “Global Reflections on Children’s Rights and the Law: 30 Years After the Convention on the Rights of the Child” (Routledge Press 2021). She is currently working on a project to reframe family law governing collaborative family-making.



**Annie Pullen Sansfaçon** (PhD Ethics, Social work, DeMontfort University, UK) is Professor at the University of Montreal’s School of Social Work and hold the Canada Research Chair on Transgender Children and their families. She is also the scientific director of the multidisciplinary research team on transgender youth and their families. Her research is aimed at understanding the experiences of well-being of transgender children. Rooted in anti-oppressive and trans affirmative perspectives, she proposes interventions and methodologies that support their empowerment.



**Catherine Regis** is a full professor at the University of Montreal Law Faculty, holder of a Canada Research Chair in health law and policy ([chairesante.ca](http://chairesante.ca)), co-founder of the Health Hub – Policy, Organizations and Law ([h-pod.ca](http://h-pod.ca)) and founding member of the JusticIA ([justice-ia.com](http://justice-ia.com)) research group. She is also a researcher at the Centre de recherche en droit public (CRDP), the University of Montreal Hospital Research Center (CRCHUM), the Observatory of the Social Impacts of AI and Digital Technology (OBVIA), and Special advisor and Associate vice-rector with planning and strategic communication at the University of Montreal. Catherine also participated in the creation of the Montreal Declaration for a responsible development of artificial intelligence as a member of its scientific committee.



**Rhona Schuz** is a Full Professor of Law at the Academic College of Law and Science Israel and Adjunct Professor at the Faculty of Law, Bar Ilan University. Before moving to Israel, she was a lecturer in law at the London School of Economics. She has an MA in law and an LLM from the University of Cambridge and a PhD from the University of London. Rhona has written extensively in the areas of child law and private international law, with particular emphasis on children's rights and international child abduction. In addition to numerous articles, she has published two books, *A Modern Approach to the Incidental Question in the Conflict of Laws* (Nijhoff, 1997) and *The Hague Child Abduction Convention: A Critical Analysis* (Hart, 2013). The latter has been widely cited in the literature and by appellate courts in a number of jurisdictions.



**Maayan Sudai** is an Assistant Professor of Law and of Women and Gender Studies at the University of Haifa. Maayan holds a doctorate (SJD) from Harvard Law School where she concentrated on health law, bioethics, and STS studies. Maayan's current research agenda examines the interaction between law and science as epistemological systems, focusing on how social movements use these systems to shape knowledge and policy. Her published work explores the incoherence between legal and scientific conceptions of sex and gender, and examines how legal professionals construct the meaning of these concepts in law and policy.
